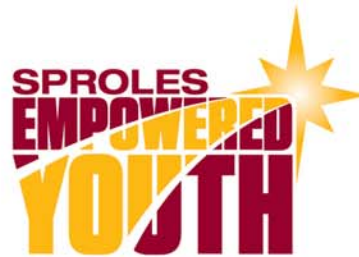
Waiver and release of liability must be signed!

I furthermore agree to indemnify and hold the released parties harmless from the payment of any and all judgments, settlements, costs, disbursements, and attorney fees associated with any released party having to defend or investigate any claim, action or proceeding of any type arising out of my (or my child's) participation in the event, including, but not limited to, claims for breach of contract, negligence, strict liability, or otherwise.

My (or my child's) indemnification obligation and agreement to release from liability does not, however, absolve the released parties from any liability, damages, costs, disbursements, or attorney fees incurred due to their intentional or reckless conduct. I acknowledge that this release agreement is executed in exchange for the opportunity to participate in the event. I have read (or had read to me) this release agreement in its entirety and understand its implications. By voluntarily signing this agreement, I understand that I may be giving up substantial rights. Nevertheless, I agree to be bound by its terms and warrant that I have the full authority and capacity to do so.
